



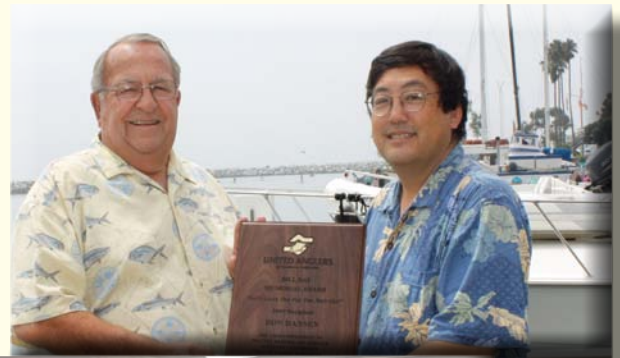

# PRESIDENT'S MESSAGE

## Finishing Strong

Much of 2010 was very hard for us and very hard for recreational anglers in general. It seemed that, despite valiant efforts and the fact that we always seemed to have science and logic on our side, we were always getting shot down. I think it made us all skeptical.

That all changed on October 1st. That's when the California Superior Court ruled in favor of retired Sportfishing Association of California (SAC) President Bob Fletcher, the claimant in a lawsuit brought against the MLPA initiative by our legal team on behalf of recreational anglers. The court ruled that the MLPA Blue Ribbon Task Force and Science Advisory Team are state agencies, and therefore violated California's Public Records Act when they failed to give important information we had requested.

This win means they now have to give us this information. The real importance of this victory, however, is what our legal team expects to find about how the flawed MLPA process has been run when they examine these documents.

It's surprising what a win can do for morale and energy. We need to feed on this and redouble our efforts. We need to turn this victory into a shot in the arm for member involvement and fundraising. In other words, we need to finish the year strong.



We have a skilled legal team that has proven it can get results. I don't have to tell you, however, that legal action is expensive. It's why UASC has formed the Ocean Access Protection Fund (OAPF) and is actively seeking donations at events and online at [www.oceanaccessprotectionfund.org](http://www.oceanaccessprotectionfund.org).

oceanaccessprotectionfund.org. Donations made to OAPF go directly to support anglers' legal challenges to the MLPA initiative.

All this activity has also stretched UASC's resources—both human and financial—extremely thin. We need more volunteers to step up over the next few months and help both in our office and out in the field. We need to make our November 13th Crab Feed Fundraiser a big success. I encourage you to get off the sidelines and take action now by purchasing tickets to this fun event. fisherman in California. His entire adult life has revolved around sport fishing in Southern California, dating back to the 1950s when he purchased San Clemente Sportfishing. Today he is best known as founder of Dana Wharf Sportfishing, one of the most popular and successful landings on our coast.

Hansen has led a life dedicated to giving back to the community, the industry and the ocean environment. He has served on the Pacific Fisheries Management Council (PFMC) and was its Chairman from 2003 to 2009. He is currently Commissioner for the Pacific States Marine Fisheries Commission, a special appointment he recently received from the governor. Hansen is also the Special Assistant to the Director of the PFMC. In recognition of his hard work and dedication over the years, Hansen received the National Oceanic and Atmospheric Administration

(NOAA) Fisheries "Sustainable Fisheries Award" in 2007.

# OCEAN ACCESS PROTECTION FUND NOW TAKING ONLINE CONTRIBUTIONS TO SUPPORT LEGAL ACTION ON BEHALF OF ALL CALIFORNIA ANGLERS

The recently formed Ocean Access Protection Fund (OAPF) has launched its online contribution program through [www.OceanAccessProtectionFund.org](http://www.OceanAccessProtectionFund.org), allowing this division of United Anglers of Southern California to collect online contributions for legal challenges against California's Marine Life Protection Act (MLPA) as well as future threats to recreational access to ocean and coastal waters.

The new site was designed to make it easy for individuals, fishing clubs and businesses to make secure contributions to the OAPF using major credit cards or Paypal. "Contributions to the OAPF will be used solely to support legal action against the MLPA and other policies that restrict recreational fishing access to California waters," said UASC President Steven Fukuto.

While the OAPF is being spearheaded by UASC, it will be representing the interests of anglers, businesses and others frustrated with the MLPA implementation process across the Southern, Central and North Central California regions. According to Fukuto, the OAPF

was created to support legal causes of action against policies that do not recognize the conservation efforts of fishermen and impact recreational anglers' access to the ocean. The MLPA is the first project being undertaken by the organizers of the fund.

UASC will direct this effort in collaboration with the Partnership for Sustainable Oceans (PSO) and its industry/conservation partners, which include — in addition to UASC — the American Sportfishing Association, Berkley Conservation Institute, supporting members of the Avalon Tuna Club, Coastside Fishing Club, International Game Fish Association, Kayak Fishing Association of California, National Marine Manufacturers Association, NorCal Kayak Anglers,

Shimano Sport Fisheries Institute, Southern California Marine Association, Sportfishing Association of California and Watermen's Alliance.

In addition to the website launch, the organization also unveiled its Mission Statement, logo and tagline — Access for All Californians. "Establishing an identity for the OAPF is critical, and our logo is an important part of this. It clearly shows that we are fighting for ocean access for all anglers, whether they fish from the shore, pier, boat or kayak. In fact, we're working on behalf of all people who treasure

open access to our ocean and the coast, from sport divers and surfers to swimmers and beachcombers," Fukuto added.

Legal action on behalf of California anglers has already begun. A top California law firm has been retained and has already filed suit against the flawed MLPA implementation process. The verified petition for writ of mandate and complaint was filed on May 28, 2010 at the Sacramento County Courthouse for violation of the California Public Records



Act, seeking declaratory and injunctive relief. The first court hearing was October 1, 2010 in Sacramento Superior Court, where the judge found in favor of angler's groups and required the MLPA initiative to turn over critical information (see story page 9). "We believe we have a strong case, an excellent legal team and a sound long-term strategy that can protect ocean access for all Californians. What we need — now more than ever — is for people throughout the state to support this important effort," said Fukuto.

# LEGISLATIVE UPDATE: GOVERNOR SCHWARZENEGGER SIGNS RIGS-TO-REEFS BILL

## *UASC Co-Founder and CARE Board Member Bill Shedd Has Been Active in This Effort For 10 Years*

On September 30th, Governor Arnold Schwarzenegger put his pen to AB 2503, a bill sponsored by Assembly Speaker John Perez. The actual act of signing this important legislation didn't take long, but it was the culmination of a decade long effort by fishermen, divers and other advocates to protect important marine habitat off our coastline.

United Anglers of Southern California has long been involved in promoting Rigs to Reefs — the concept of maintaining the underwater portions of California's 27 soon-to-be-decommissioned gas and oil drilling platforms off our coast. Bill Shedd, co-founder of UASC and President of AFTCO, has been closely involved with the process for 10 years and is an active board member of CARE (California Artificial Reef Enhancement). CARE has been leading the effort to maintain the diverse and important marine ecosystem that lives below these drilling platforms.

Shedd has gone along on dive trips to demonstrate

to the press and policymakers the abundance of marine life on these "constructed reefs." The pilings, cross bars and drilling tubes are completely covered with strawberry anemones, mussels, scallops, crabs and starfish, while fish of all types and sizes find shelter around the structure. The seafloor underneath these rigs is covered with decades worth of cast-off mussels shells, and these "shell mounds" are important habitat for many juvenile fish, including rockfish. The underwater portions of these platforms make up the state's largest network of artificial reefs with an area about the size of 75 football fields.

AB 2503 provides for each offshore platform to be evaluated individually. If partial decommissioning is found to be environmentally beneficial, part of any financial savings (versus complete removal) will be reinvested back into the ocean.

"Protecting this important habitat has been a focal point of UASC for a long time," said UASC President Steve Fukuto. "The signing of this bill is an important step in the right direction, for anglers, divers and all who value the ocean."

# SACRAMENTO SUPERIOR COURT RULES IN FAVOR OF CALIFORNIA RECREATIONAL ANGLING GROUPS

## *Ruling Confirms MLPA Blue Ribbon Task Force and Science Advisory Team Are State Agencies, Forces Public Access to Critical Information*

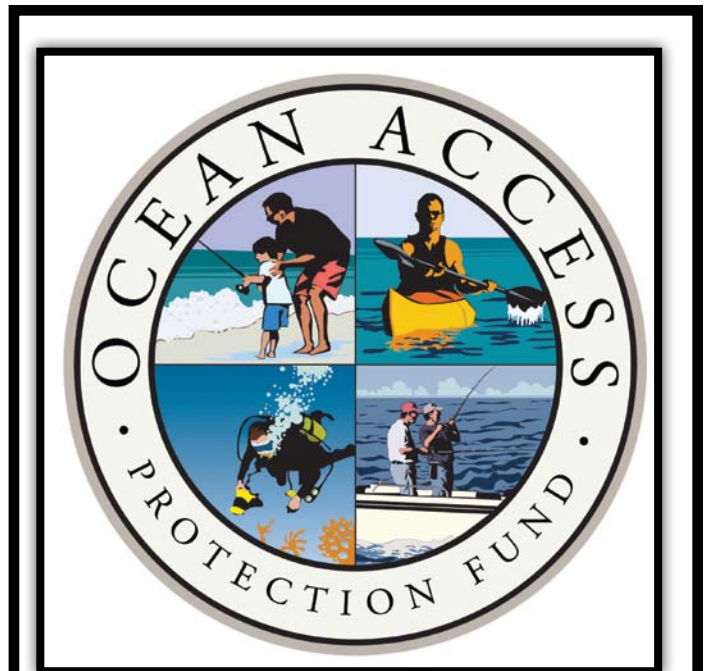
A California Superior Court issued a ruling on Friday, October 1 confirming that the Marine Life Protection Act Blue Ribbon Task Force (BRTF) and Master Plan Team (MPT — also known as the Science Advisory Team) are state agencies and therefore compelled by California’s Public Records Act to share information with representatives of angling/conservation organizations working to protect recreational ocean access. The ruling came in response to a lawsuit filed by Allen Matkins Leck Gamble Malloy & Natsis LLP, on behalf of Robert C. Fletcher, former president of the Sportfishing Association of California, a member organization in the Partnership for Sustainable Oceans.

“This is a very significant ruling to the many recreational angling groups and individuals across California who have invested so much time and energy in the MLPA process,” said Fletcher, former president of the Sportfishing Association of California (SAC). “This ruling validates our long-held position that the groups implementing the MLPA and making decisions that result in closures of large areas of the Pacific Ocean to recreational activities cannot carry on as if they were not agencies of the state. Like any other state agency, these groups are responsible to the public and must do their work in an open and transparent way that the public can learn about through laws like the Public Records Act,” added Fletcher.

“Now we’ll get to see information that has been previously hidden from us about key decisions made by the BRTF and MPT,” said Steven Fukuto, president of United Anglers of Southern California and director of the Ocean Access Protection Fund (OAPF), a division of UASC formed to rally anglers and sportsmen across California in support of legal action. “Our success in this lawsuit will allow us to shine a light on important decisions that have been

made in the dark. We have every confidence this ruling will help us better understand how decisions have been made under the MLPA, and to examine the legal basis for those decisions on behalf of anglers and sportsmen across the state,” added Fukuto.

“This ruling is an important first step, but we’re going to need more financial assistance from anglers to support our efforts to fight this flawed process in the courts,” Fukuto said. 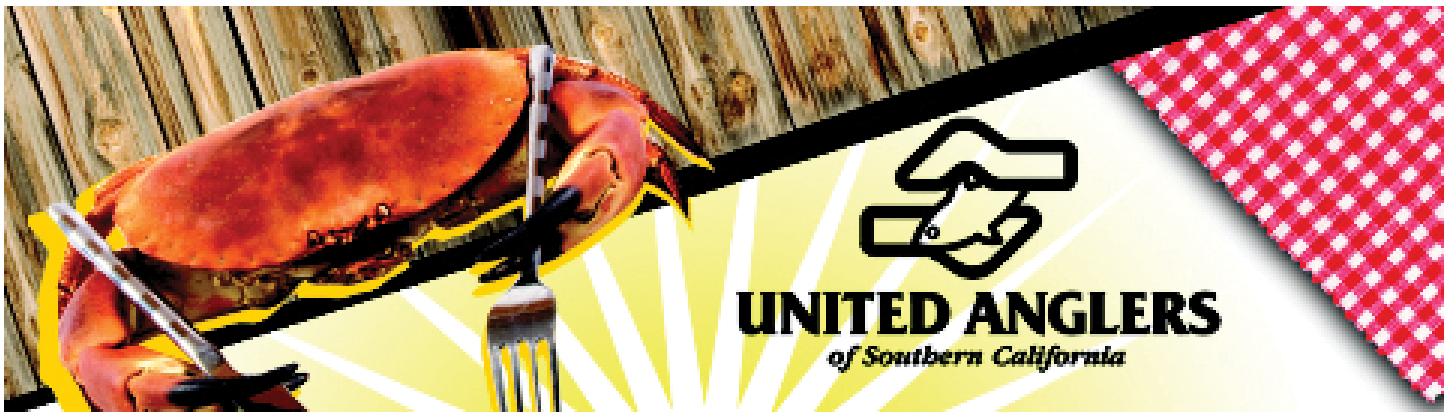
## THE UASC CODE OF ETHICS

Following is our Code of Ethics, which we believe UASC members, and all anglers, should pledge to follow every time they venture onto the water.

These are not just words or rules. These principles form a solid foundation for each angler to build a better sense of conservation and sportsmanship. Following this Code of Ethics will help protect our ability to fish and ensure a clean environment and healthy fish stocks for the future.

The Ethical Angler:

1. Promotes through education and practice ethical behavior in the use of natural resources.
2. Avoids spilling and never dumps any pollutants, such as gasoline and oil, into the aquatic environment, or into storm drains that lead to the ocean.
3. Disposes and recycles all trash including worn-out lines, leaders, and hooks in appropriate containers and helps to keep fishing sites litter-free.
4. Takes all precautionary measures necessary to prevent the spread of exotic plants and animals, including live baitfish, into nonnative habitats.
5. Learns and obeys angling and boating regulations, and treats others with courtesy and respect.
6. Keeps no more fish than needed for consumption, and never wastefully discards fish that are retained.
7. Practices conservation by carefully handling and releasing alive all fish that are unwanted or prohibited by regulation, as well as other animals that may become hooked or entangled accidentally.
8. Practices safe angling and boating by following the law and using common sense practices to prevent injury to themselves, others or property.
9. Uses tackle and techniques that minimize harm to fish when engaged in catch and release fishing.
10. Shares fishing knowledge, skills and ethics with others.

# YOUTH FISHING UPDATE: UASC/FRIENDS OF ROLLO

UASC/Friends of Rollo Director John Rowe knows that 2010 will end up a landmark year for the long-running youth fishing program. He expects that when this year is over that Friends of Rollo will reach its annual goal of taking 5,000 kids fishing. When pressed for an overall tally since the non-profit organization — named for Capt. James “Rollo” Heyn — began taking groups of kids fishing many years ago, he wasn’t sure.

He figures that Friends of Rollo has taken more than 50,000 youngsters fishing so far — and the actual number may be closer to 60,000. One thing is certain; it’s a lot. And Rowe and Friends of Rollo show no sign of slowing up, even if today’s tough economy is requiring creative thinking a willingness try different things.

For example, the past couple of years Friends of Rollo has coordinated and sponsored “Kids Fish Free” Days at landings up and down the coast. Different from fully sponsored Rollo group trips, these events are a great way for families to experience the thrill of ocean fishing aboard local ½ and ¾-day boats. Each paying adult that day can take along up to two kids for free. These free fishing days are done twice a year; two weekend days in June to coincide with National Fishing and Boating Week and two in September at the end of the traditional peak season. “These trips are a great way to go for people who want to fish with their kids, but don’t have an organized group,” said Rowe.

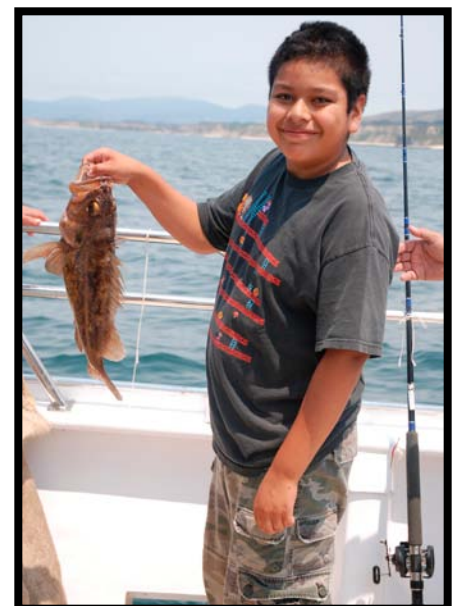
Friends of Rollo is branching out in other ways, as well. In recent years, the organization has become contributing or anchoring sponsors for popular community family activities like the Crystal Pier Fishing event put on by Capt. Ron Baker and the Young Anglers Tournament at Shelter Island Pier presented by the San Diego Sportfishing Council, I.G.F.A and the Port of San Diego. “Working with these established events is a great way to help and reach hundreds of kids at once. What’s more, these family events are a great way for fishermen of all ages to have fun together,” added Rowe.

Friends of Rollo has also formed a working relationship with Fish For Life ([www.fishforlife.org](http://www.fishforlife.org)), a unique non-profit that specializes in sponsored fishing trips for special needs and discipline challenged individuals. Fish For Life’s ½-day trips are complimentary to selected groups and go much deeper than a day on the water. These trips provide a special day filled with personalized attention, food, prizes, and especially fun and love.

With all this going on, you might think that Friends of Rollo could rest on its laurels. Instead, the organization is working on new ways to take kids and families fishing. “We’re also looking at ways to provide fishing trips at local Southern California lakes, where the entire family can join in the fun without a

long time commitment. We think this is going to be a great way to expand the size and scope of our youth fishing efforts,” said Rowe.

Taking kids fishing is important to the future of our support. All anglers should support the fundraising efforts of Friends of Rollo. Tickets for the 2011 Friends of Rollo Fundraising Raffle are already available for \$10. # FISHING CLUB FOCUS

## FIB'ers CHRISTIAN FISHING CLUB

To say that the FIB'ers Fishing Club is different than your typical fishing club would be an understatement. First of all, FIB'ers is a Christ-centered interdenominational club and outreach ministry of Newport Mesa Church in Costa Mesa. Secondly, since its founding in 1983, the club has had no formal membership, no initial fees or yearly dues. And then there's that name. FIB'ers stands for Fishermen In Business, but the tongue-in-cheek reference to the typical angler's fondness for exaggeration is unmistakable.

Club expenses are met through donations only. A person interested in joining simply gets on the club's mailing list, and participation in meetings and club activities makes them an "full-fledged" member. FIB'ers has about 150 people on its active email list and typically has about 35-40 fishermen attend each monthly meeting. These take place the third Thursday of the month at the Newport Mesa Church.

The club works hard to get interesting speakers who can help make members better anglers, and this helps drive strong attendance. "I remember our June 17, 2010 meeting in particular," said Rick Chalmers, a FIB'ers member and recent winner of UASC's Volunteer of the Year award, "because the Lakers were playing the Celtics in Game 7 of the NBA finals. Even with the biggest sporting event of the year going on, we still had 38 people show up to learn about fishing from Cory Sanders of MC Swimbaits."

The FIB'ers put together monthly charter trips between May and October, where members and guests can fish together in a fun, family-friendly atmosphere. They also do two FIB'er Junior trips each year, where the focus is on providing a fun

and healthy environment for youngsters to enjoy fishing and the great outdoors. As part of the club's ongoing outreach to the community, the FIB'ers put together a whale watching trip each spring and two ½-day fishing trips over the summer for the Olivecrest Children's Home.

There are also FIB'ers surf fishing events, private boater tournaments, social events and many more activities. "Our events provide great opportunities for men, women and youngsters to get together and enjoy fishing, fun and fellowship," said club spokesman David Shill. "We're finding that there are many fishermen out

there looking for a fun, comfortable and relaxed environment that's different from your typical open party trip or even club charter. This is exactly what FIB'ers is all about.
